

Did You Know?

- Louisiana is among the 10 fastest-growing states for high-tech employment, according to Tech America's 12th annual Cyberstates report. The report shows Louisiana gained 4,349 high-tech jobs, an 11.3-percent gain, between 2002 and 2007.
- In April 2009, Forbes ranked the nation's top 10 mid-sized cities for jobs. Three Louisiana cities made the list: Lafayette was No. 3, Baton Rouge was No. 7 and Shreveport-Bossier City was No. 8.
- Louisiana ranked only behind California and New York in filmmaking in 2008.





Legislative Update

• A Bill was passed providing a 5-percent refundable tax credit for capital investment expenditures to modernize an existing facility in its product lines, unit, or entire operations to increase efficiency and productivity by more than 10 percent. It can allow the credit if the Louisiana facility is at imminent threat of closure and consolidation with another facility in another U.S. state or country and is in competition for expenditures within

the company's portfolio of plants. It requires a minimum of \$5 million for capital investment per project, and credits would be taken over a five-year period. The Louisiana Department of Economic Development must approve applications for the program. Credits can be earned and taken in the year that the project is placed in service only after the LED provides a tax credit certificate.
