

Did You Know?

- Arkansas taxpayers may receive an income tax credit for the purchase
 of equipment used exclusively for reduction, reuse or recycling of solid
 waste material for commercial purposes, whether or not for profit, and
 the cost of installation of such equipment by outside contractors. Taxpayers receiving credit under this Act for the purchase of machinery and
 equipment shall not be entitled to any other state or local tax credit or
 deduction based on the purchase of the machinery or equipment, except
 normal depreciation.
- The amount of the tax credit shall equal 30 percent of the cost of eligible equipment and installation costs. Credits may be carried over a maximum of three consecutive years following the taxable year in which the credits accrued. Eligibility is determined by the Arkansas Department of Environmental Quality (ADEQ). Such equipment must be used in the collection, separation, processing, modification, conversion, treatment or manufacturing of products containing at least 50 percent recovered materials of which at least 10 percent is post-consumer waste.

Legislative Update

- The Arkansas Legislature held its first-ever "Fiscal Session" during 2010 to approve the state budget. No major economic development bills were passed.
- Gov. Mike Beebe plans to ask the Legislature for a half-cent reduction in the state sales tax on groceries. That follows a \$500-million reduction in the tax over the past four years.
- Beebe's budget plan also includes a 2-percent increase in per-pupil funding for K-12 education, as well as an additional \$7 million for the state's four-year, two-year and technical institutions of higher education.
- Bills filed for the 2011 session which convenes on Jan. 10 include a proposal to eliminate the 4.9-percent state capital gains tax on profits earned on new investments in Arkansas-based companies.
