Legislative Update

- In May, Gov. Fallin signed into law a bill that requires all state agencies and higher education institutions to improve their energy efficiency and energy conservation measures by 20 percent by the year 2020. If the goal is met, Oklahomans could save between \$300 million and \$500 million in energy costs over the next 10 years.
- Oklahoma passed the Oklahoma Energy Initiative, which will serve as a strategic program designed to create, advance and promote new and existing energy research and development efforts in Oklahoma.
- Oklahoma created and launched OKJobMatch.com, a one-stop-shop website for students and job-seekers to find job matches and for employers to find workers with the skill sets they need.
- Oklahoma passed the Water for 2060 Act, which establishes a statewide goal of consuming no more freshwater in 2060 than is consumed currently in the state. The bill also creates an advisory council that will recommend solutions for finding new sources of water and creating greater efficiencies in the use and storage of water.

Did You Know?

- •The total economic impact of Oklahoma's 38 American Indian tribes on the state is estimated at \$10.8 billion a year, according to a study by Oklahoma City University's Steven C. Agee Economic Research and Policy Institute. Gaming businesses account for \$7.6 billion of that total, the researchers found.
- Oklahoma ranked No. 1 in cost of living and No. 4 in cost of doing business in CNBC's Top States for Business in 2012.
- Oklahoma City ranked sixth among all large metros in the nation in job growth from 2010 to 2012, according to Career-Builder.com. The city added nearly 29,000 jobs, ranking right above Dallas and San Francisco.
- According to the U.S. Census Bureau, Oklahoma had the highest rate of median household income growth in the nation last year. From 2010 to 2011, Oklahoma's median household income rose 12.4 percent.
