

Legislative Update

Business Leaders for Michigan in a December note wrote, "In a move toward more efficient and effective public service, the Regional Prosperity Initiative was enacted to encourage regions to collaborate and promote economic growth." Other actions included "reducing state debt, reducing taxes for small and medium-sized businesses, and reducing obsolete or unnecessary regulations."

 Gov. Snyder in October signed a bill to enhance the state's business improvement zones by streamlining the process to establish a zone, authorizing zones to merge

with other zones, allowing for an enforcement mechanism for the lien of unpaid assessments, and to reduce the likelihood that a zone will be dissolved by the assessable property owners.

- A measure to increase the minimum wage from the current \$7.40 was sent to committee. So was a measure to repeal "prevailing wage" laws.
- A measure to clean up corporate income tax reporting law as it pertains to certain flow-through entities became law.

Did You Know?

- Michigan is one of the fastestgrowing venture capital states in the country, with VC funding up 69 percent in the state since 2008.
- Michigan's 15 public universities are responsible for more than 120,000 jobs, with spending and earnings accounting for \$23.9 billion in economic activity, according to a Dec. 2013 report from the Anderson Economic Group commissioned by the Presidents Council, State Universities of Michigan.
- Michigan posted merchandise exports of \$25.4 billion to Canada in 2012, 44.6 percent of the state's total merchandise exports.
- Forty of Michigan's 83 counties touch at least one of the Great Lakes.
- Snapshot 1954: In 1954 the Hudson Motor Car Co. merged with Nash-Kelvinator to become American Motors, and car production was moved to Wisconsin. Hudson and Nash vehicles were eventually discontinued by AMC under the leadership of company president George W. Romney, who later served as governor of Michigan and U.S. Secretary of Housing and Urban Development.

REASONS WHY MICHIGAN MEANS BUSINESS

- Michigan's economy is at a 10-year high
- 200,000 new jobs added, unemployment down 40% to 8.4% (as of 5/13)
- Personal income up 3.5%, matching the national average
- A \$1.5 billion budget deficit eliminated, saving \$20 billion in long-term liability (\$2,000 per resident)
- A job-killing Michigan Business Tax replaced by a flat 6% Corporate Income Tax, catapulting the state's tax ranking from #49 to #7
- Leads the nation with 88,100 new manufacturing jobs since 2009
- State taxes reduced by at least 80% for businesses of all sizes
- Workers' compensation premiums decreased by 7% per year the last two years, the best of any Midwestern state
- The Michigan Unemployment Trust Fund holds a \$1.5 billion surplus,
 versus a previous \$3.9 billion unfunded liability, eliminating tax penalties
- The state's "rainy day" development fund has grown to \$505 million
