Legislative Update

• The Texas Enterprise Fund (TEF), the largest deal-closing fund of its kind in the nation, was reauthorized for the 2014-15 biennium with an estimated \$120 million available for qualifying projects. The Texas Emerging Technology Fund (TETF) received a \$50-million appropriation.

• Tax measures from the 2014 session create an R&D tax credit with the option of choosing the franchise or sales tax; create a sales and use tax refund for data centers agreeing to invest \$200 million over five years and create at least 20 qualifying jobs in the county; and allow regions to develop County Transportation Reinvestment Zones.



DID YOU KNOW?:

- Texas last year was ranked the No. 1 exporting state in the nation by the US Census Bureau for the 12th consecutive year. The state's export revenues in 2013 were up 5.4 percent from 2012, to nearly \$297.7 billion.
- Now 25 years old and about half developed, the 17,000-acre AllianceTexas development in

Fort Worth is home to 400 companies and a daily work force of 40,000.

• With 1,300 subsidiaries of foreign companies employing some 460,000 people in the state, Texas was the only state to send a governor (outgoing Gov. Rick Perry) to the 2014 World Economic Forum in Davos, Switzerland.
