### Legislative Update

- The legislature passed a comprehensive transportation infrastructure funding package to address Michigan's aging roads and bridges.
  Funding will come from a combination of sources that will be phased in over the next few years including increased vehicle registration fees, raising the fuel tax and indexing it to inflation by 2022, and equalizing taxes on all types of fuels.
- House Bill 4370 was included in the transportation package to provide relief to taxpayers in the form of an increase in the homestead property tax credit while expanding eligibility for the credit both to homeowners earning \$61,000 per year or less and to renters at the rate of 23 percent of rent paid.
