

Legislative Update

- In June, Gov. Kasich signed HB 429, extending a workforce training youcher program to automotive technicians who work in auto dealerships and repair shops. The vouchers reimburse employers for the cost of training existing workers.
- · Also in June, Gov. Kasich signed a bill to restore a state tax exemption on the sale of precious metal bullion and "investment" coins. The exemption, repealed after a scandal in 2005 involving workers' compensation funds invested by a member of the state Board of Regents, went back into effect on January 1.
- Kasich also signed legislation intended to improve community health planning. ORC 3701.981 requires tax exempt hospitals to submit community health improvement plans to the state for online posting.
