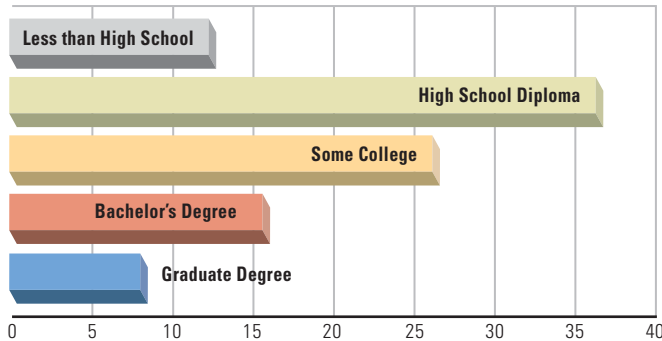

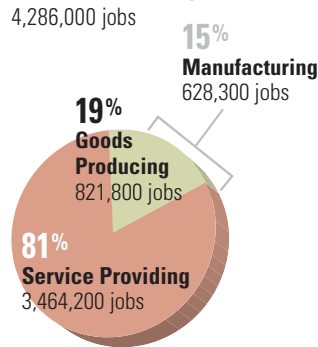

Did You Know?

- Only 15 states had a lower tax burden than Ohio in fiscal 2009, according to April 2010 analysis by the Federation of Tax Administrators in Washington, D.C. That's nine places better than 2005, when Ohio embarked on a program to change the state's tax system.
- As one of the 11 states (plus D.C.) named as winners of U.S. Dept. of Education "Race to the Top" funding, the state will receive \$400 million to support comprehensive education reform.
- A policy paper developed by the Ohio Economic Development Association calls for streamlining of Ohio's incentives and work-force development programs, and the creation of an Ohio Jobs Closing Fund. It also calls for joining a \$1-billion Great Lakes angel fund for tech-based companies. And, it says, "every large manufacturer in Ohio should be fully briefed on the millions of dollars in cost savings available from the Public Utility Commission of Ohio's recently created electric incentive program."

Legislative Update

- A legislative summary published in June by Bricker & Eckler cited the Ohio General Assembly's successful passage of a renewable and advanced energy jobs bill, SB 232, which reforms the tax code for renewable and advanced energy generators utilizing technologies such as wind, solar, co-generation, advanced nuclear and clean coal. The measure exempts qualifying projects from tangible personal property taxes and real property taxes. "Under the bill, the effective tax rates for eligible projects will drop from approximately \$100,000 to \$7,000 (the PILOT) per megawatt of energy generation from a solar facility, and from approximately \$40,000 to no more than \$9,000 (the PILOT) per megawatt of generation from a wind facility," said the summary.
- Then-Gov. Ted Strickland in June signed into law a measure implementing language for the casino constitutional amendment that won voter approval in November 2009.
