Legislative Update

- Minor changes recommended by the state
 department of commerce provide clarity to the Tax
 Reimbursement Incentive, passed during the 2014
 legislative session, which provides a tax credit of
 up to 30 percent for up to 15 years on new income
 tax, sales tax and payroll taxes paid as a result of
 a new qualifying project. Amendments revise the
 definition of new jobs, application requirements, the
 agreement with the applicant and applicant reporting
 requirements.
- A new law appropriates \$36.1 million to the Department of Commerce for fiscal year 2016, limits the number of full-time equivalent positions to 46, and transfers \$1.75 million from the General Fund to the Idaho Opportunity Fund. Another new law appropriates nearly \$67 million in FY 2016 to the Division of Professional-Technical Education, a 6.3-percent increase.

Did You Know?

The Boise Metro ranks at 94.7 percent of the national average in ACCRA's Cost of Living Index. Business costs in the Boise Valley are a third lower than in California and Washington.

The Geothermal Energy Association's 2015 report notes that Idaho has 88 MW of planned capacity additions in the works, fourth in the nation.

The US Dept. of the Interior's Bureau of Land Management (BLM) manages nearly 12 million acres of public lands in Idaho (almost one-fourth of the state's total land area), including 16 Wild and Scenic Rivers covering 318 miles.


