2020 GDP (in millions of current US\$) \$156,770


Legislative Update

House Bill 2101 extends the current transfer of the first \$10.5 million credited to the Expanded Lottery Act Revenues Fund (ELARF) from ELARF to the Kan-grow Engineering Fund – KU, the Kan-grow Engineering Fund – KSU, and the Kan-grow Engineering Fund – WSU. Each fund receives \$3.5 million in each fiscal year.

Among other measures, SB 159, the state omnibus budget for FY 2021 and FY 2022 passed in May, increased funding for four-year and two-year public and private colleges and technical schools totaling \$53 million.

SB 65 ensures that companies will no longer need to go through the Kansas Industrial Training/Retraining (KIT/KIR) programs to qualify for the High Performance Incentive Program (HPIP), leaving vital training funds to be used in more strategic ways. In addition, the bill allows for up to 50% of tax credits earned through HPIP to be transferred, helping to ensure that companies can fully use earned credits

The STAR Bonds program in Kansas has been continued with updates that include third-party feasibility studies to be engaged by Commerce, community engagement summary requirements, and other transparency measures.




