



## LEGISLATIVE & POLICY UPDATE

Amendments to HB 1539 exclude on-site backup electric generation from the definition of electric energy conversion facilities. This enables on-site backup electric generation that exceeds 50 megawatts and is not connected to the power grid to no longer be subject to the North Dakota Public Service Commission's Siting Act. The move allows businesses and data center developers to streamline processes and local approval to add on-site backup generation in line with environmental protections.

SB 2390 creates a new section of the North Dakota Century Code to create a Rural Catalyst Committee and grant program. The committee will award reimbursable grants up to \$500,000 to communities with projects designed to improve quality of life, education and economic development opportunities. At least 50% of grant funding will be allocated to communities with a population under 1,500 residents.



## LEGISLATIVE & POLICY UPDATE

HB 15 aims to streamline and encourage the development of electric generation facilities through shortened permitting timelines for the Ohio Power Siting Board to make decisions within 195 days max. For priority investment areas such as brownfield sites and former coal mines and those with a minimum 25-year lease, easements, rights-of-way or ownership of a potential property, this timeline is further accelerated. The bill also includes tax assessment rate reductions for pipeline, electric, rural electric and energy that companies can take advantage of for properties going into service after December 2025.

Through SB 54 the state establishes the Ohio River Commission and the Ohio Ireland Trade Commission. Within the Department of Development, the Ohio River Commission will promote economic development, marine cargo terminal operations and advance tourism for communities along the Ohio river. The creation of the Ohio Ireland Trade Commission will support new bilateral trade opportunities, advance policy issues of mutual interest, educational exchanges, mutual infrastructure investment and more.
